THIS APPLICATION WILL NOT BE PROCESSED WITHOUT THIS.

Applicant consents to any and all investigation of their credit history by NEDCO Supply, including, but not limited to, retrieval of credit reports from credit reporting agencies. NEDCO Supply reserves the right to limit or withdraw the extension of credit at any time.

Applicant acknowledges that the principal place of business of NEDCO Supply and the location where performance of the credit agreement and payment is to be performed is Clark County, Nevada. The applicant agrees that in the event of suit to enforce payment, venue and jurisdiction will take place in Clark County, Nevada, or in the jurisdiction where shipment originates, at the option of NEDCO Supply.

If credit is extended, the applicant agrees and understands that full payment is due the 25<sup>th</sup> of the following month after the invoice date, regardless of non-payment from your customer. The applicant agrees to pay a late charge of 1.5% (18% per annum) on any past due balance. The applicant further agrees to pay all of NEDCO's collection costs, to include a \$250 lien fee and/or a bond fee and attorney fees should an action be brought to collect this account--including seller's actual attorneys' fees. All purchases subsequently made shall be subject to these terms and conditions.

All goods are delivered FOB shipping point. Prices are subject to change without notice, unless a written quotation with an expiration date is provided by NEDCO Supply. Goods may be returned with permission. All returned merchandise is subject to restocking and return-to-manufacturer freight fees. Special orders are non-cancellable and not returnable.

Shortage and/or damage claims will not be considered unless your organization initiates the claim on the shipping document at the time of receipt of product. Warranty, when applicable, is limited solely to such warranty as the manufacturer furnishes. NEDCO Supply sells items "as is" and gives no warranty of its own. NEDCO Supply will assist you in filing your claim under the manufacturer's warranty provisions.

Any change in the business structure, ownership, credit worthiness, or any other fact which might relate to NEDCO Supply's decision to continue extending credit will be reported to NEDCO Supply's Credit Department in writing, sent by certified mail, return receipt or by such other means as will generate a written receipt by the Credit Department. Any other delivery of such information is presumed to be ineffective to give notice.

Applicant agrees that NEDCO Supply may elect, at its option, to serve preliminary notices related to all projects for which materials are purchased and may, at its option, enforce any and all Mechanics Liens, Stop Notices, and/or Bond rights and related remedies. The availability of such multiple remedies shall not, in any way, affect buyer's obligation to pay for all goods purchased pursuant to the open account being applied for herein or any purchase made thereon. The failure of NEDCO Supply to enforce such 3<sup>rd</sup> party rights shall not diminish, dilute, or be a defense to any claims against the applicant.
